 - i. Mike Holtzclaw introduced new Director of Business Operations, Crystal Gonzales. Informed the board of other vacant positions including Facilities Manager, Facilities Coordinator, HR Technician, and the recent resignation of Executive Assistant to the Chancellor, Kelley Garrett.
 - ii. Reported a successful UNM-LA open house and ribbon cutting of building 6.

 - i. Paul Allen announced they are hiring for full time faculty positions in chemistry and biology.

 - iii. Reported that spring registration has opened with new course offerings in Actinide Science and Chicana and Chicano Studies.
 - iv. Associate of Arts in Early Childhood Education was approved by the UNM Senate.

v. Mike Holtzclaw reported meeting with Los Alamos High School leadership to discuss the concerns brought by parents and students to the last Advisory Board meeting concerning the LAECCA program. Principal Renee Dunwoody met with each family to address the issue. Will be offering the final course needed to complete certificate and for one student, UNM-LA is working with LANL to grant credit to be used towards the missing capstone course. Currently in the negotiation process of working that out.

 - i. Danielle Gonzales reported an exact match in headcount as fall of last year.
 - ii. Reported a successful job fair in collaboration with the Los Alamos Chamber of Commerce in which 27 businesses participated and about 100 job seekers attended.
 - iii. Received a lot of positive feedback from the LANL Career Day hosted on UNM-LA campus in which high schools local and in the surrounding areas attended. Hope to make this an annual event moving forward.
 - iv. Registration for spring 2025 began. Conducting targeted outreach.

UNM-Los Alamos Advisory Board Report January 13, 2025 Chancellor's Report

Staffing

Paul Allen, Dean of Instruction, has resigned and his last day is January 13, 2025. Irina Alvestad, who currently is our Associate Dean, will become Interim Dean on January 14, 2025. She will remain in that role until we find a new dean. I am in the process of interviewing search firms to help us with the recruitment.

Legislative Session

This year, the legislative session is a 60-day session. It begins on January 21^{st} and goes through March 22^{nd} .

Website Redesign

We are currently working with a company to do a complete redesign of our website. Our current website is out-of-date and is trying to be all things to all audiences. We really want the focus of our website to focused on future and current students as well as the external community. We will be creating an internal site for faculty and staff. The new website will be designed using current best practices and will move away from stock photos to ones that are taken locally.

Construction Updates

Building 2 – We just started the new roofing and stucco repair/update on the building. It should be completed within about 6 to 8 weeks. The building has had many leaks, due to the old roof, and once the roof is replaced, we will begin repairs on the interior spaces that we damaged by the water. We are also ready to start the lighting updates throughout the second floor. Our current lights and fixtures will be replaced with more modern looking fixtures and, most importantly, the lights will be upgraded to LED, which will be more cost effective to operate.

Building 5 – Progress is being made on the remodel on the ground floor of the building. This area, which used to house the ceramics studio, welding lab, and machine shop is being extensively updated and expanded. The ceramics studio is moving from building 5 to building 8 so that we can increase the square footage and capacity of our welding and machining programs. We are also adding a second bathroom in that area. As part of this project, we are also updating the bathrooms on the main floor so that they are up to modern ADA standards.

Building 8 – We are just wrapping up the design for the new ceramics and art studios in building 8. Once design is complete, we will begin construction sometime this semester and those studios should be ready for classes in fall of 2025.

Front entryway and staircase – Construction on this project should begin sometime in February and should be completed by the start of the fall semester in 2025.

Title V grant support

I will have some brochures to hand out to the Board with some of the recent marketing collateral supported by the Title V grant.

Faculty/Staffing Changes:

- MaryJane Giesler, long-time English Lecturer, retired in December.
- Linda Nash, Adult Education Program Manager, resigned in December.
- Jennifer Armstrong, Academic Coach for English, has resigned.
- Cindy Budge, Biology lecturer, resigned in December.
- Chemistry and Biology faculty applicants have been invited to campus for final interviews and teaching demonstrations in January.

Scheduling/Enrollments

- We have completed a first draft of the Summer and Fall schedules.
- Spring schedule is live and open for registration.

Curriculum

• Our Instructional Designer, Kevin Roseberger, has developed new online course review forms and will be deploying these on a rotating basis in all online courses to ensure continguing quality online instruction at UNMLA.

Partnerships and Initiatives

- After meeting with LANL representatives in December, we have secured one more year of reduced funding for the BSME program. Negotiations are underway for an additional 5-years, during which we will need to make the program self-supporting.
- With HED, we have partnered on a Broadband grant application, that, if successful, would net the college almost \$1 million dollars for students in the Broadband program.

Faculty-related Activities

• Dr. Virginia Grant was awarded an \$1800 Research Allocations Committee (RAC) grant to begin an ecocriticism library, and some collaborative events to start an ecocriticism project at UNM-LA.

Enrollment Update

The numbers below reflect the headcount and student credit hours for spring 2025 as of 01/05/2025. Also included are the headcount and student credit hours from spring 2024, at this same last year, for comparison. Headcount and student credit hours are slightly down.

 Spring 2025 – (11 days prior to the start of the semester). Headcount: Spring 2025 -770; Spring 2024 -911 HC is down 18.31% from this time last spring semester. Student Credit Hours: Spring 2025 -3,238; Spring 2024 -3,952 SCH is down 18.07% from this time last spring semester.

Upcoming

- Classes for spring 2025 begin on Tuesday, January 21st. Advising and outreach efforts are in full swing.
- Our **Community Internship Collaboration (CIC)** will host a **Meet & Greet** event on Wednesday, February 5. The event will be from 10 am to 2 pm in the Student Center. This is an opportunity for students to meet with the local businesses who will offer internships in the spring semester. A hot chocolate bar, snacks, and t-shirts will be provided.
- The spring **Job Fair** will be held on April 10th. Though it will be held at Fuller Lodge this semester, this event continues to be a collaboration between UNM-LA and the Chamber. Our advisors will hold resume and interview skills workshops leading up to the fair.

Student Highlight

 UNM Los Alamos student Paul Alcazar was awarded the N3B Danny Nichols and Dennis Huddleston Memorial Scholarship. This is a \$9,000 unrestricted scholarship that is available to students enrolled at UNM-Los Alamos or Northern New Mexico College who are pursuing an education and career in environmental remediation, radioactive and hazardous waste management, or energy.

Staff Changes

Ingrid Goldstein resigned her position as Senior Student Enrollment Specialist Associate as of 1/3/25. We are currently reviewing the job description and will be posting for the position as soon as possible.
