#### **Dr. Brent Pickett**

Born and raised in Kansas, I attended Wichita State University, earning a B.A. in Political Science. I then attended the University of Colorado at Boulder, earning an M.A. and Ph.D., also in Political Science. I served as assistant professor at Chadron State College (CSC) in Nebraska, eventually going on to serve as the



Social Science department chairperson, Honors Program director, and was promoted to associate professor. After nine years at CSC, I took a position leading the University of Wyoming's sole branch campus, in Casper. I had that position for nine years as well. I forged strong relationships with the local school district, Casper's economic development agency, and several social service agencies and foundations, leading to increased programs and enrollment. I led us through the Higher Learning Commission process of being formally recognized as a branch campus rather than as an additional location and secured the community support needed for a name change, from the University of Wyoming/Casper College Center to UW Casper (UWC). I also engaged in fundraising, increasing the number of scholarships available and increasing the corpus of UWC endowments from the \$25,000 it was at when I started to over \$1,000,000. I continued to engage in research and was promoted to full professor.

After nearly a decade of leading the branch campus, I returned to faculty so I could focus on teaching and research. The branch campus, unfortunately, did not do well in my absence, with falling enrollment and declining morale. In early 2019, the UW provost asked me to again lead UWC. After agreeing to do so, I embarked on an inclusive strategic planning process that aimed to restore confidence in the branch campus and increase enrollments. We have proceeded to execute it well. Over the past six years, enrollment has more than doubled. As a result, we have also increased the number of faculty and added new programs. Morale is strong.

I am deeply committed to fostering accessible, quality higher education opportunities. I work hard to ensure student success, including that students are in a relationship-rich setting that has many opportunities for internships, undergraduate research placements, and other high-impact practices. For the length of my career, I have worked to advance this for all students, regardless of background, socioeconomic status, or other barriers. I enjoy working with faculty and staff and work hard to ensure that shared governance and transparency in decision-making are upheld. In my spare time, I enjoy fly fishing, reading, and spending time with my family.
